
Crisis Intercept Mapping for Suicide Prevention Among Service Members, Veterans, and their Families

Phase 2: Community Strategic Action Planning

During the past year, SAMHSA's Service Members, Veterans, and their Families (SMVF) Technical Assistance (TA) Center held a Crisis Intercept Mapping workshop within your community team to identify critical inter-organizational gaps and opportunities for strengthening the crisis care continuum in your area. This workshop concluded with the development of a Crisis Intercept Map and a Goals document which identified high-level, targeted objectives, decided on by your team addressing the essential elements for suicide prevention for SMVF in your community.

During this final phase of the CIM workshop process, we will be joined by expert facilitators to:

- structure the identified issues for root cause analyses
- review successful processes implemented by previous teams
- determine the who, when, where, and how for action item implementation
- identify resources needed
- define metrics and measures to demonstrate how your collaboration over the past year will result in outcomes for the community




